#### CONSIGNMENT AND SALE FEES:

\*The following fees apply to all animals sold or unsold on sale day:

Consignment Fee is \$150. Commission is 10% of sale price. State mandated insurance fee is \$.50 per \$100 of horse value. Yardage fee \$40 per horse. No "No Sale Fee".

## TERMS & CONDITIONS

- All consignment forms must be submitted with the required consignment fee and original registration papers. The Seller is responsible for obtaining a current negative Coggins test and must present valid documentation on sale day.
- Mares selling in foal must be accompanied by a completed and signed breeder's certificate, or a written statement from the stallion owner confirming that the breeder's certificate will be issued at foaling.
- Southwest Horse Sale and its affiliates act solely as auctioneers for all sales and potential sales. They assume no responsibility for errors, misunderstandings, misrepresentations, rejection of bids, failure of payment, condition of the horse, or any disputes arising between the Buyer and Seller/Consignor/Owner.
- The Seller/Consignor/Owner is required to fully disclose any known defects, vices, or undesirable habits. Such disclosures must be announced when the horse enters the sales arena and/or at the time of sale. Southwest Horse Sale and its affiliates are not responsible for loss, injury, or damage to horses, equipment, or persons caused by accident, fire, theft, or any other circumstance before, during, or after the sale. **WARNING UNDER LOUISIANA LAW**  
An equine activity sponsor or equine professional is not liable for injury to or the death of a participant resulting from the inherent risks of equine activities, pursuant to La. R.S. 9:2795.1.
- Upon execution of this contract, the Seller/Consignor/Owner agrees not to sell or dispose of the horse by private sale. If this agreement is breached and the horse is sold privately, Southwest Horse Sale is entitled to a 10% commission based on the sale price, in addition to the consignment fee.
- Once a horse is consigned, it is expected to enter the sales ring when its number is called. If a consigned horse is a "no show," the Owner agrees to pay a \$500 fee immediately following the final entry of the sale. If registration papers are on file, they will not be released until the fee is paid in full.
- Only horses officially consigned to the sale are permitted on the sale grounds. All horses sold before, during, or after the sale are subject to a 10% commission, in addition to the consignment fee. All consignments must be sold through the sale ring.
- The consignment fee is non-refundable. Horses withdrawn from the sale for any reason other than death, extreme illness, or serious injury will be subject to the \$500 "no show" fee.
